The fund's investment objective consist mainly of achieving long-term capital gains by making investments in securities and other investment objects and well distributing the risks.


The fund may freely take all investment decisions, as its performance is not linked to any reference index.

The fund may also use derivative instruments of all kinds for hedging and investment purposes. There are no restrictions whatsoever regarding currency allocation. In order to minimize the currency risk, assets that are not held in the fund's currency of account might temporarily or permanently be

Investment Strategy

Main investment of the Class is Nova Real Estate Fund (CZ) - an AIF, focused on top quality commercial real estate in Central Europe. Commercial real estate represents a typical diversification tool for any investment portfolio. Commercial properties in lucrative locations offer attractive value preservation and stable return for a conservative investor. It invests only in prime commercial properties. Its focus on quality of tenants, attractive locations with enhancement potential and real estate meeting the highest requirements for quality and technical standards are main aspects of the fund investment policy and its value proposition to investors.




